New Policy Deadlines

Effective immediately, there has been a drastic change regarding important paperwork needed to complete your monthly claim.

It is **IMPERATIVE** that all **LICENSE**, and **AP-**

PLICATION changes (meals, meal times, day care hours, addresses, phone numbers) **MUST reach the DPA office on or before the 19th of each month.**

If your information is

received after the due date, your claim can/ will be impacted.

Recipes of the Month

Fruit 'n Cheese Snack Mix



What You Need

1 oz. KRAFT Cheddar Cheese, cut into bite-sized pieces
1/4 cup whole strawberries, stems removed, quartered
1/4 cup seedless red or green grapes, cut in half

Make It

PLACE cheese in 1 side of resealable sandwich-size plastic bag; loosely tie pie cleaner or twist tie around middle of bag. Place fruit in other end of bag; seal bag, then twist pipe cleaner tightly to separate cheese from the fruit.

Curl

ends of pipe cleaner to resemble antennae of a butterfly.

Refrigerate

until ready to serve. Untwist pipe cleaner, leaving bag sealed. Gently shake bag to mix fruit and cheese. Open bag and enjoy!

What you Need

2 pkg. (4-serving size each) JELL-O Vanilla Flavor Fat Free Sugar Free Instant Pudding
4 cups fat-free milk
47 NILLA Wafers, divided
5 to 6 medium ripe bananas, sliced (about 3 cups), divided
2 cups thawed COOL WHIP LITE Whipped Topping

Make It

PREPARE pudding with milk as directed on package.

SPOON 1/2 cup pudding in bottom of 2-qt. serving bowl. Top with 8 wafers, generous layer of sliced bananas and 1 cup pudding. Stand 12 wafers around outside edge of dish. Continue layering 12 wafers, sliced bananas, 1 cup pudding, 15 wafers, sliced bananas and remaining pudding. Cover.

Refrigerate

3 hours or overnight to soften cookies. To serve, spread whipped topping over pudding. Garnish with additional banana slices, if desired.
